## Position Information

Note: The duty location for this position can be in either McLean, VA or Bethesda, MD site.

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.



- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.)

## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

**\*\*\*OPEN UNTIL FILLED: This announcement will be open until the position is filled. Cut off points are scheduled in two-week increments. After each cut off point, all compliant applicants received during the previous two-weeks will be reviewed for consideration.\*\*\***

## Component Mission

National Security Partnerships synchronizes IC support and whole of government efforts with federal, state and local governments, the private sector and the Department of Defense, ensuring IC outreach is coordinated, timely and relevant. It also provides key leadership for activities in four domains that operate across national sectors – aviation, maritime, space and cyber -- bringing the IC's activities in these domains into alignment, and facilitating coordinated engagement internal to the ODNI, across the IC and with the rest of the federal government.

## Major Duties and Responsibilities (MDRs)

- Serve as NIM Space & Technical Intelligence, Space Intelligence Issue Manager for the Deputy Director of National Security Partnerships (DD-NSP) overseeing intelligence activities, determining the state of collection and analysis, and identifying gaps and customer requirements related to space and counter-space intelligence topics. Advise the DD-NSP, NIM S&TI, NIMC, and other ODNI leadership on critical space and counter-space intelligence issues, developments, opportunities, and threats. Lead stakeholders and interagency working groups and liaise with community elements to drive intelligence integration for NIM S&TI on issues related to space and counter-space intelligence. Represent the NIM S&TI at meetings, conferences, and other fora. Demonstrate superior oral and written communication skills, including superior ability to draft and edit written reports of varying length and complexity, and to communicate effectively with audiences of varying seniority and expertise on IC space and counter-space issues. Support opportunities to advocate for and defend resources and assess return-on-investment for existing NIM S&TI-sponsored initiatives and campaigns. Utilize superior interpersonal skills and superior ability to work effectively in both independent and in team or collaborative environments.

## Mandatory and Educational Requirements



- Expert knowledge of, and demonstrated senior-level experience in, conducting, coordinating and leading IC-wide intelligence collection and analysis efforts focused on threats to US space capabilities and infrastructure and representing these efforts to IC customers in the policy and defense communities. Expert knowledge of, and demonstrated senior-level experience in, providing intelligence support to IC and DOD acquisition organizations and efforts. Superior leadership, interpersonal and management skills, oral and written communication skills, including ability to communicate effectively with audiences with diverse backgrounds, and the abilities to think strategically as well as to identify needs, requirements, develop recommendations, and evaluate outcomes against goals and objectives. Demonstrated experience leading teams of government and contractors and leading interagency working groups or committees on issues related to space and counter-space.

## Desired Requirements

- Expert knowledge of the Intelligence Planning, Programming, Budgeting and Execution (IPPBE) process, Intelligence Community Capabilities and Requirements (ICCR) processes and DOD's Joint Capabilities Integration and Development System (JCIDS). Minimum of two years of post-degree experience working in the private or academic sector on the design and engineering of space or other DOD systems.

**Applicants from federal agencies outside the IC** must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
