## **INSIDER THREAT HUB OPERATIONS COURSE - 2026**

This two-day course introduces the minimum standards for Executive Branch Insider Threat Programs that exercises basic functions of hub operations to deter, detect, and mitigate potential insider threats. Potential Risk Indicators (PRI's) will be examined, risk levels identified, as well as covering various mitigation recommendations using practical, scenario-based exercises designed to enhance the participants ability to perform case management capabilities. The class may include General Counsel, a Behavioral Specialist, and other specified insider threat professionals.

**Target Audience:** Federal Government employees (military, civilian, and contractors) who directly support Government Insider Threat Programs, and other multidisciplinary stakeholder positions. Registrants are limited to .gov or .mil email correspondence for distribution of materials for official use.

Method of Instruction: Microsoft Teams, In-Person (as indicated).

**Course Length:** 16 hours (two eight-hour days for virtual courses). All course times are Eastern Time.

**Prerequisites**: None required, however, attendees should have a foundational knowledge of insider threat hub operations. The following online training courses from the Center for Development of security Excellence (CDSE) are highly recommended prior to attending the course:
