## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual.
- A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

## Component Mission:

The mission of the National Counterintelligence & Security Center is to lead and support the U.S. Government's counterintelligence (CI) and security activities critical to protecting our nation; provide CI outreach to U.S. private sector entities at risk of foreign intelligence penetration; and issue public warnings regarding intelligence threats to the U.S.

## Major Duties and Responsibilities:

This is a developmental position for junior officers seeking to grow their CI and Security acumen at the national level. Officers selected via this posting will have the opportunity to work in multiple directorates within NCSC based on their background, skills, interests, and current NCSC mission needs. Incumbents' duties will include a number of the following:

- Help advance the objectives of the National CI Strategy: Protecting the nation's critical infrastructure, reducing threats to key US supply chains, countering the exploitation of the US economy, defending American democracy against foreign influence, and countering foreign intelligence cyber and technical operations.
- Support efforts to reform the security clearance process and ensure a trusted workforce.
- Be part of a national task force leading the National Insider Threat program.
- Support outreach efforts to multiple stakeholders including the private sector; federal, state and local partners; foreign partners; and the public.
- Produce analytical issue papers, background papers, resource issue papers, and other analytic products applying extensive subject matter knowledge to support the senior leadership in making informed programmatic decisions.

## Mandatory Requirements:

- Strong oral and written communications skills.
- Flexibility and willingness to explore new opportunities and develop new skills.

## Desired Requirements:

- Some prior experience engaging with organizations performing CI or Security missions.

- A two-year trial period is required for all new permanent appointments to the ODNI.
