# Introduction

**IC on the Record.** On August 10, 2013, President Obama directed the U.S. Intelligence Community (IC) to make public as much information as possible about its surveillance programs with the goal of enhancing transparency. As part of this effort, President Obama directed the Director of National Intelligence (DNI) to create website to "serve as a hub for further transparency." On August 21, 2013, the Office of the Director of National Intelligence (ODNI) announced the creation of the Tumblr site *IC on the Record*. The goal of *IC on the Record* is to "provide the public with direct access to factual information related to the lawful foreign surveillance activities carried out by the Intelligence Community." Since its inception, the site has served as the posting location for thousands of pages of released documentation, including previously classified information, as a means to provide "comprehensive explanations of the authorities under which the [IC] conducts foreign surveillance" and to address methods of collection, use of collected data, and oversight and compliance.

Additionally, this tracker will also occasionally capture relevant documents posted to other sites, such as dni.gov, that may not otherwise appear on ICOTR.

**The ICOTR Transparency Tracker.** ODNI's Office of Civil Liberties, Privacy and Transparency (CLPT) created this "transparency tracker" document to track, categorize, and chart the information being released to the public on *IC on the Record* for the purpose of assisting the public in identifying and retrieving relevant information, facilitating research, and gauging the effectiveness of the IC's transparency efforts since August 2013. Because *IC on the Record* is an important public outreach tool for the IC, analyzing the amount and types of information publicly released on *IC on the Record* provides a helpful and comprehensive way to assess the IC's progress in enhancing transparency. Specifically, this transparency tracker consists of a series of statistical summary charts followed by a detailed index of documents.

**Summary Charts.** The summary charts provide data, by percentage, about the number of releases per year and the subject matter categories to which the released documents are related. ODNI – and CLPT in particular – look to these summary charts as a snapshot of the ODNI's transparency efforts and the types of information that have been made public since 2013.

**Document Index.** The document index attempts to list every released posting, whether a document, statement, memorandum, etc., on *IC on the Record*. Note that some entries provide a posting date that is earlier than the creation of *IC on the Record* in August 2013; this is because the entry was originally publicly posted on another IC website and the original public posting date was kept when it was later placed on *IC on the Record*.

**Subject Matter Categories.** Each document is categorized in accordance with six subject matter categories, which are reflected in the Summary Charts. Most of these subject matter categories are legal authorities described in the content of a

posting. In instances where a posting touched on multiple subjects, the posting was placed in the category of the greatest prevalence. In addition, placing a posting in a specific subject matter category took precedence over placing a posting in the “General” subject matter category. The FISA subject matter category is further broken down by subcategory. The “subject matter” categories used to chart the posted information are described below:

### **1. FISA**

This category covers information related to activities conducted pursuant to the Foreign Intelligence Surveillance Act of 1987 (FISA), 50 U.S.C. Sec. 1801, et al. It includes information pertaining to subsequent amendments to FISA, including the telephony metadata business record provisions formerly authorized under Section 215 of the USA PATRIOT Act; the FISA Amendments Act (FAA)’s Section 702; and the USA FREEDOM Act. Any posting (except those under the FOIA category specified below) containing references to FISA are counted in this category. The types of FISA postings contained herein include Foreign Intelligence Surveillance Court (FISC) opinions and related FISC pleading documents; transparency statistics concerning the use of FISA authorities; Congressional reports, testimony and other documents relating to FISA; and IC fact sheets and public statements to further transparency about the government’s lawful use of FISA authorities.

### **2. Executive Order 12333**

This category covers information relating to U.S. intelligence activities authorized pursuant to Executive Order (EO) 12333, as amended, other than those activities that are also carried out pursuant to FISA. Such postings include information about U.S. signals intelligence (SIGINT) collection activities such as the Signal Intelligence Reform Reports. Also included in this category are releases pertaining to Section 2.3 of EO 12333, which permits the IC to collect, retain, or disseminate information concerning United States persons only in accordance with specific established procedures approved by the Attorney General (commonly referred to as Attorney General Guidelines). Any Congressional reports, testimony and other documents relating to U.S. intelligence activities authorized pursuant to EO 12333 are also included in this category.

### **3. Presidential Policy Directive 28**

This category covers information related to Presidential Policy Directive 28, Signals Intelligence Activities (PPD-28). PPD-28 reinforces current practices, establishes new principles, and strengthens oversight, to ensure that in conducting signals intelligence activities, the United States takes into account not only the security needs of our nation and our allies, but also the privacy of people around the world.

### **4. President’s Surveillance Program (PSP)**

This category covers information pertaining to the President’s Surveillance Program (PSP), a collection of intelligence activities initiated after 9/11 and concluded in February 2007. Specifically, in October 2001, President Bush “authorized the Secretary of Defense to employ the capabilities of the Department of Defense, including the National Security Agency (NSA), to collect foreign intelligence by electronic surveillance in order to detect and prevent acts of terrorism within the United States. President Bush authorized NSA to collect: (1) the contents of certain international communications, a

program that was later referred to as the Terrorist Surveillance Program (TSP), and (2) telephony and Internet non-content information (referred to as “metadata”) in bulk, subject to various conditions.” Despite the finite nature of the PSP program, PSP is included here as its own category due to the substantial number of documents falling under its description.

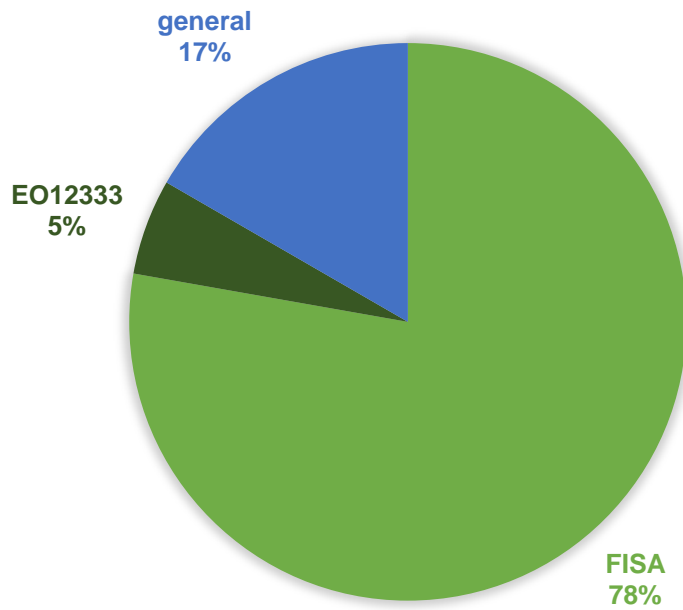
## **5. FOIA**

This category covers any documents released in response to a Freedom of Information Act (FOIA) request that were made available specifically through the FOIA "Proactive Disclosure" program, initiated on February 16, 2016, on *IC on the Record*. ODNI is one of several federal agencies participating in this FOIA Proactive Disclosure program; the purpose of this program is to make records requested via FOIA more readily available to the public. If a posting was made through this specific FOIA program, it is included in this FOIA category on the summary chart regardless of the subject matter contained within the posted document. However, subject matter subcategories are provided for sorting purposes, although not counting purposes.

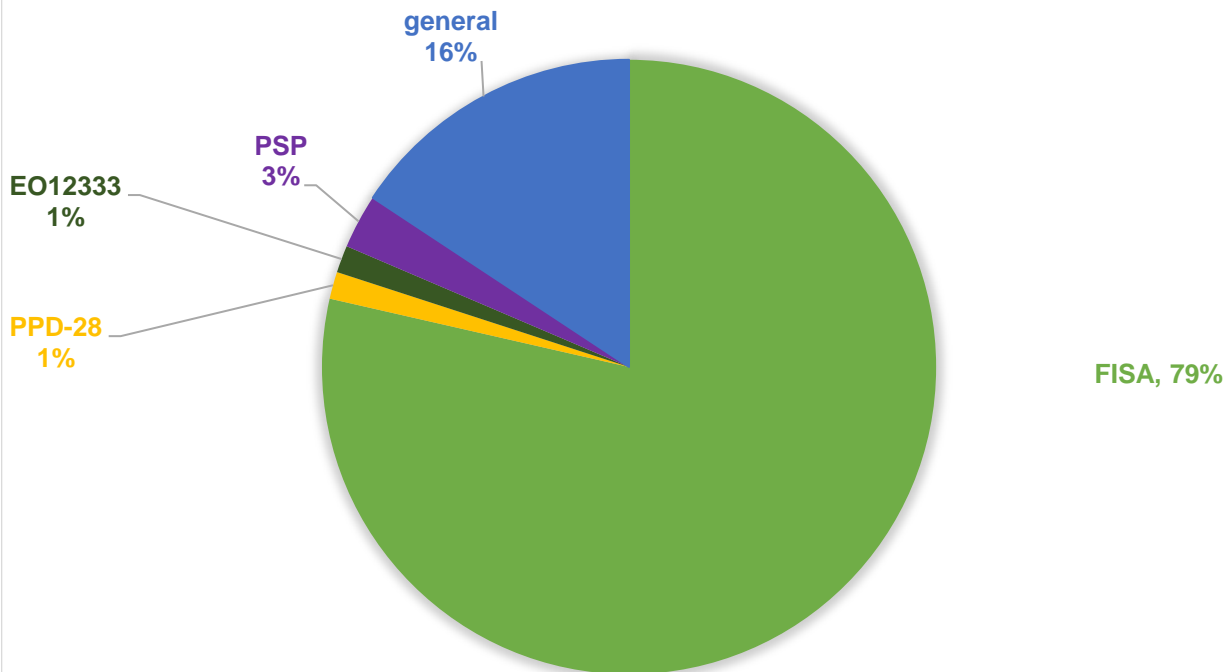
## **6. General**

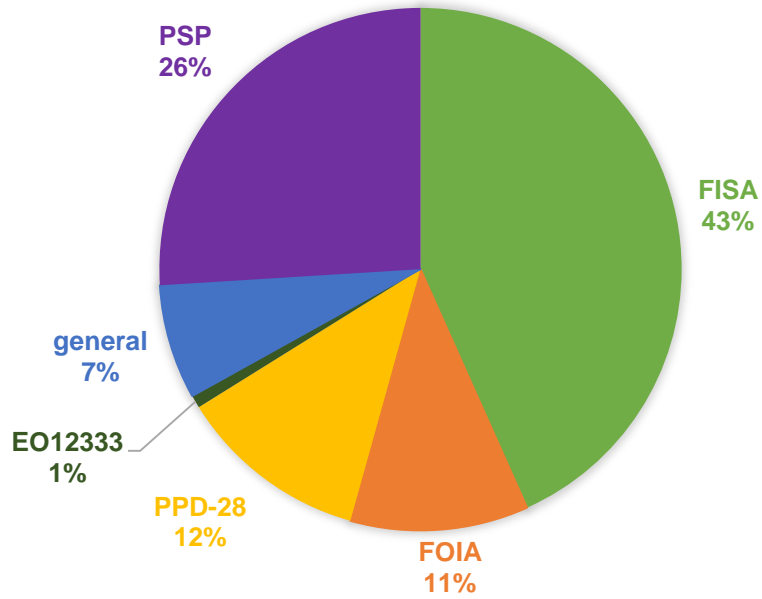

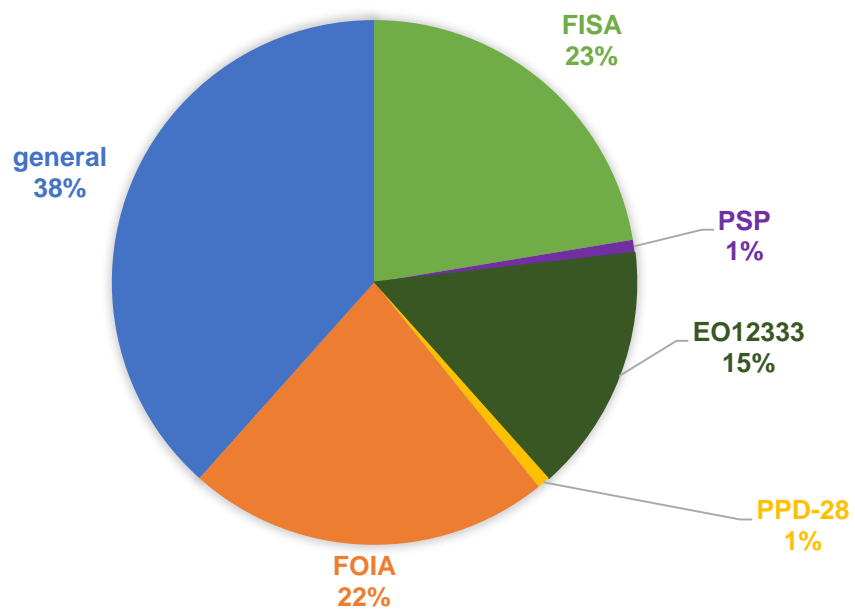
## IC ON THE RECORD RELEASES 2014



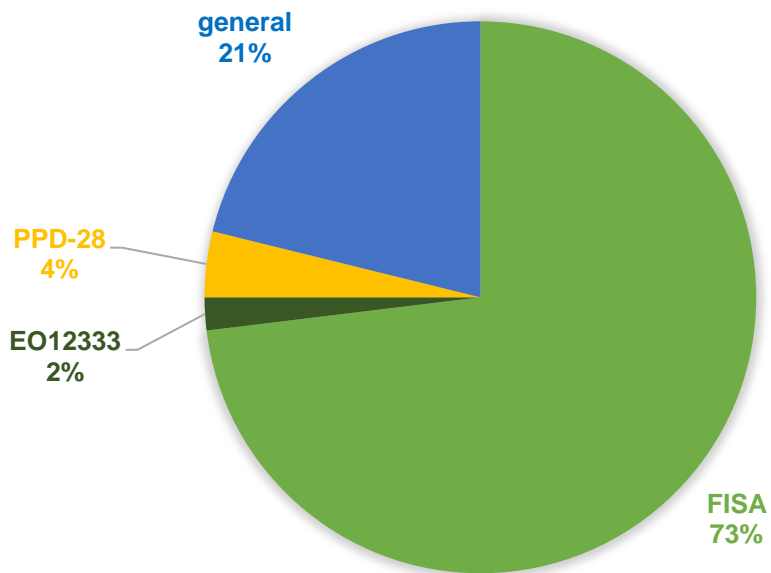

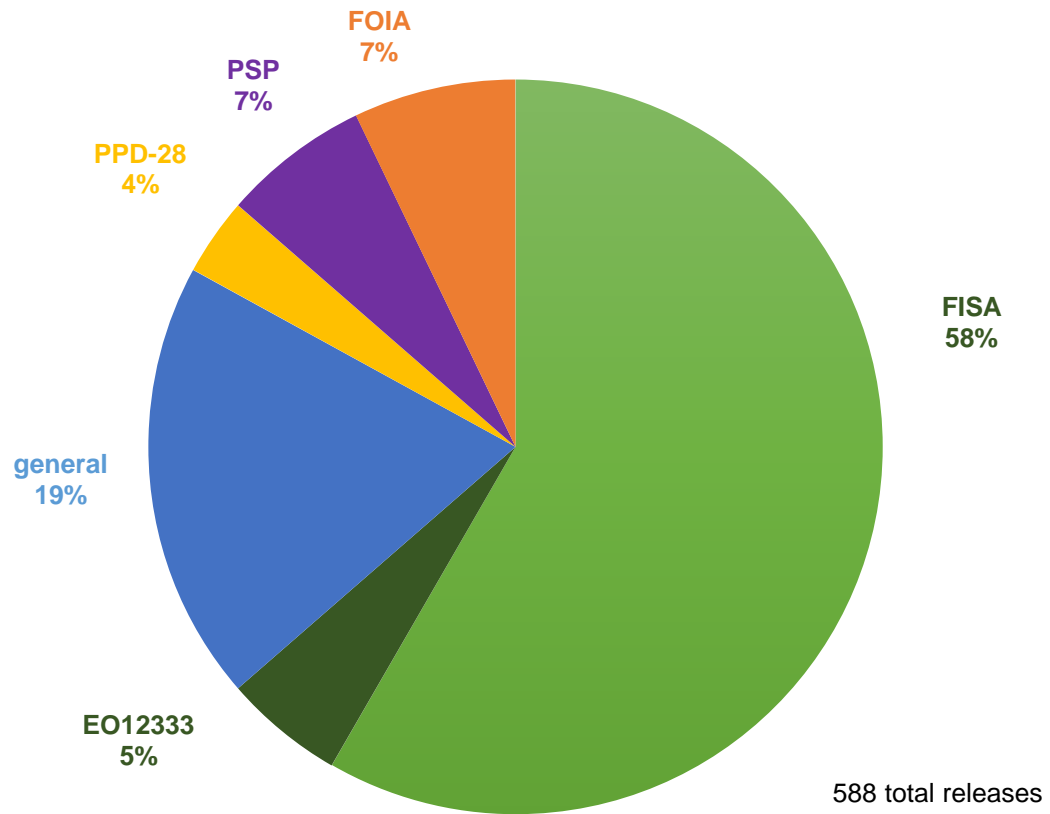
