Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:



- Current Federal Government employee at the same grade or one grade lower than the advertised grade may apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail assignment, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

Plan, develop and evaluate the related strategic planning documents in support of United States (U.S.) national security and foreign policy interests and programs.

Serve as a primary lead for efforts to evolve the role of the National Intelligence Management Council in strategic resource decisions, primarily through the production of the Intelligence Planning Guidance (IPG).

Tailor the IPG to provide the IC with unified, specific, and actionable planning guidance to address emerging and future needs. Ensure IPG alignment vertically with the National Intelligence Strategy and Unifying Intelligence Strategies, as well as horizontally with the ODNI Strategic Effects processes to support the development of the Consolidated Intelligence Guidance.

Collect, assess, adjudicate, and rank national Intelligence gaps and areas of resulting risk through repeatable methodologies. Assist in identifying potential trade-space as well as risk identification, efficiencies, and mitigation through the NIMC's IPG processes.

Manage partnerships and communicate with stakeholders across mission and enterprise to synchronize requirements and resources, and represent the Council's position.

Advise and provide subject matter expertise to MMG Group Chief, NIMC Vice Chairman, and NIMC Chairman on strategic integration and resource decisions as required.

Support initiatives that further IC mission integration, such as changes in mission posture and crisis management. Identify and raise new ideas to advance mission management, solve problems, and advance the NIM Council and the IC.



Collaborate with regional, functional, and domain NIM teams to assess the mission impact and outcomes of their respective strategies and to prioritize planning and programmatic activities in alignment with national level strategy and guidance.

Develop and advance a common lexicon of terms and definitions for NIMC-led strategies to ensure effective communication with oversight bodies, internal stakeholders, and external customers.

Support briefings to senior IC officials and other major stakeholders collaboration progress, issues and challenges.

Mandatory and Educational Requirements

Extensive knowledge of IC organizations' missions in order to develop the national-level strategies and policies necessary to support U.S. national security and foreign policy interests.

Extensive knowledge of strategy development and planning and a demonstrated ability to identify emerging trends and strategic issues and incorporate these into organizational strategic plans.

Demonstrated leadership skills and ability to lead interagency working groups, build coalitions with IC elements to achieve common goals.

Demonstrated analytical and critical thinking skills, including the ability to think strategically, identify needs and requirements, develop recommendations, and evaluate outcomes against goals and objectives.

Demonstrated ability to communicate clearly, both orally and in written reports, and to logically analyze, synthesize, and evaluate multiple sources of information for their inclusion in briefings and written documents.

Bachelor's degree or equivalent experience as determined by mission specialty area.

Desired Requirements

Demonstrated interpersonal skills and superior ability to work effectively in both independent and in a team or collaborative environment.

Experience in developing methodologies behind assessments.

Understanding of performance management principles and ability to advise organizations on the application of evaluation methods.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
