## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)



## **Salary Determination**

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## **Component Mission**

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President and the National Security Council for intelligence matters related to national security; and oversees and directs the implementation of the National Intelligence Program. The DNI leads intelligence integration and forges an intelligence community that delivers the most insightful intelligence possible.

The Deputy Director of National Intelligence for Enterprise Capacity (DDNI/EC) is responsible to the DNI for all matters pertaining to IC resources, workforce, systems, technology and infrastructure, with five reporting components: Acquisition, Procurement and Facilities, IC Chief Financial Officer, IC Chief Human Capital Officer, IC Chief Information Officer, and Systems & Resource Analyses.

The Office of the Chief Human Capital Officer (CHCO) supports the Office of the Director of National Intelligence by establishing and overseeing the implementation of the full range of Human Capital programs, processes, and policies. The CHCO has established the Strategic Human Capital Plan for the Intelligence Community (IC) that deals directly with talent, performance, and leadership to attract, engage, and unify an innovative and results-focused workforce in support of the National Intelligence Strategy—and ultimately the security of our nation. Following the IC Strategic HC Plan, the Office of the CHCO develops and implements policies, practices, and processes that leverage commonality across the IC and maximizes the strengths of individual agencies.

## **Major Duties and Responsibilities (MDRs)**

- Lead Foreign Language Program Office (FLPO's) identification of Human Language Technology (HLT) candidates for IC licenses. Work with the IC HLT Council to identify options, prioritize candidates for advocacy, and update the Foreign Language Executive Committee. Work with ODNI/Acquisition, Procurement & Facilities to understand and leverage the IC licensing process. Ensure the council understands this process, including how to participate.
- As the FLPO lead for the HLT Landscape, build an awareness of what technology advancements and projects (artificial intelligence and otherwise) are going on in academia and industry that may be candidates to bring into the IC to benefit HLT capabilities. Create a plan to explore different areas of technology and implement this plan, leveraging MITRE contractor HLT expertise and support. Provide updates to the IC HLT Council to inform, evaluate these activities, and enable decisions on future research.
- As the FLPO lead for IC HLT Capabilities, collaborate with HLT counterparts across to the IC to build and maintain FLPO's awareness and understanding of all reported IC HLT capabilities, including current status, future plans, funding, associated issues, and areas for advocacy. Track progress of IC HLT capabilities previously selected to move into IC ITE (Information Technology Environment)



and identify future candidates to move into IC ITE. When possible, identify HLT research and development projects as candidates to receive assistance in moving into operations. Provide updates to the IC HLT Council on these activities to inform, get feedback, and prioritize advocacy.

- Support and advance the HLT objectives of the IC Foreign Language Strategy, including advancing HLT requirements, and identifying opportunities to insert HLT tools in collector and analyst workflows to enhance productivity. Support FLPO and the IC HLT Council's work on establishing and updating HLT requirements. Leverage work on IC HLT Capabilities, the HLT Landscape, and IC licenses, to inform this process. Analyze the multiple sources of requirements, such as from IC Agencies, National Intelligence Managers, and language priorities, etc., to identify gaps in capabilities against requirements. Work with the council to prioritize HLT requirements and identify areas for advocacy.

## **Mandatory and Educational Requirements**

- Extensive knowledge of the role technology plays in accomplishing the foreign language mission of the IC.
- Excellent communication skills, including the ability to prepare communications (to include papers, briefings, and testimony) suitable for presentation at the highest levels of government; demonstrated ability to analyze data, determine relevant issues, identify achievable solutions, and prepare clear, meaningful communications capable of achieving the desired outcome.
- Extensive knowledge of IC and DoD, activities, missions, and requirements and a demonstrated ability to interact with community members.

## **Desired Requirements**

- Expertise in a foreign language.
- Extensive experience as a program manager.
