This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President and the National Security Council for intelligence matters related to national security; and oversees and directs the implementation of the National Intelligence Program. The DNI leads intelligence integration and forges an intelligence community that delivers the most insightful intelligence possible.

The Deputy Director of National Intelligence for Enterprise Capacity (DDNI/EC) is responsible to the DNI for all matters pertaining to IC resources, workforce, systems, technology and infrastructure, with five reporting components: Acquisition, Procurement and Facilities, IC Chief Financial Officer, IC Chief Human Capital Officer, IC Chief Information Officer, and Systems & Resource Analyses.

The Office of the Chief Human Capital Officer (CHCO) supports the Office of the Director of National Intelligence by establishing and overseeing the implementation of the full range of Human Capital programs, processes, and policies. The CHCO has established the Strategic Human Capital Plan for the Intelligence Community (IC) that deals directly with talent, performance, and leadership to attract, engage, and unify an innovative and results-focused workforce in support of the National Intelligence Strategy—and ultimately the security of our nation. Following the IC Strategic HC Plan, the Office of the CHCO develops and implements policies, practices, and processes that leverage commonality across the IC and maximizes the strengths of individual agencies.

Major Duties and Responsibilities (MDRs)

- Serve the CHCO handling the IC Civilian Joint Duty Program.
- Lead and manage policies and programs to enable and enhance collaboration, integration, and the operational capability of the IC Joint Duty Program and other mobility initiatives.
- Lead the development and institutionalization of reporting requirements and metric to assess the IC Civilian Joint Duty Program and other mobility initiatives and to identify areas for improvement.
- Lead team in the development and implementation of HC policies, programs, and procedures to ensure all IC senior officials meet the appropriate Joint Duty requirements in accordance with Intelligence Community Directive (ICD) 601 - Intelligence Community Civilian Joint Duty Program and ICPG 660.
- Lead team in the planning, production, coordination, and dissemination of the IC Civilian Joint Duty and program metrics.



- In collaboration with the IC Joint Duty Community of Practice, oversee the formulation, coordination, execution, and evaluation of IC-wide HC policies and programs for IC Civilian Joint Duty and coordinate with IC elements to ensure that standards and requirements are met.
- Incorporate effective management techniques to motivate, mentor, and promote a culture of knowledge sharing and teamwork.
- Lead the preparation and coordination of analyses, correspondence, briefing papers, and other products focused on innovative Joint Duty and mobility strategies and solutions regarding HC program assessments.

Mandatory and Educational Requirements

- Knowledge of a rotational program and Federal human resources policies and practices emphasizing occupational structures, relationships, and competencies.
- Excellent ability to plan, design, develop and implement innovative and complex HR strategies and solutions in a multi-agency environment.
- Excellent oral and written communication skills, including the ability to clearly convey complex information to senior levels of management.
- Outstanding interpersonal skills and the ability to work effectively, independently, and in a team or collaborative environment, to include interfacing with military, government and non-government senior level officials.
- Expert ability to direct taskings, assess and manage performance, collaborate on goal setting, and support personal and professional development of all levels of personnel.
- Expert analytical and critical thinking skills, including the ability to think strategically and identify needs and requirements.

- Experience authoring, or interpreting and executing, language in the Consolidated Intelligence Guidance.
- Experience development requirements for or managing an HRIS system, application or tools.
- Experience as a first-level team lead or supervisor.
