Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of National Intelligence for Intelligence Integration (DDNI/II) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. DDNI/II is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DDNI/II is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DDNI/II is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

- Serve as NIM-EA Director for Korea, supporting the NIM in directing and overseeing national intelligence activities; setting collection, analysis, and intelligence operations and collaboration priorities on behalf of the ODNI, in consonance with the National Intelligence Priorities Framework and direction from the National Security Council Staff.
- Oversee and monitor efforts to assess the state of collection, analysis, intelligence operations, and resources gaps. Develop NIM-EA senior level strategies to identify and mitigate gaps. Ensure progress against NIM-EA strategies and assess the effectiveness of these strategies.
- Oversee and assess goal setting in accordance with NIM-EA senior level strategies.
- Lead stakeholders and liaise with community elements to drive greater intelligence integration, perform outreach, and ensure resources and priority attention is given to targets.
- Evaluate and determine the state of analysis through the assessment of the quality of analysis and ensure competitive and alternative analysis is conducted on high-priority topics.
- Support opportunities to advocate for and defend resources, as required.
- Build and apply deep expertise on intelligence coordination and collaboration.
- Support efforts to integrate the IC and remove impediments to compartmented collaboration.
- Lead assessments to leverage best practices and lessons learned.
- Guide and monitor NIM-EA governance structures to ensure decisions are made through the appropriate channels.
- Support briefings to senior IC officials and other major stakeholders collaboration progress, issues and challenges.

Mandatory and Educational Requirements

- Expert knowledge of IC organizations; IC mission posture, structures, capabilities, processes, and policy development.
- Superior leadership and mission management skills, with demonstrated ability to lead interagency working groups and build coalitions with IC elements to achieve common goals.
- Superior ability to manage strategic and tactical level topics, and develop innovative recommendations and solutions for improvement.

Desired Requirements

- Superior interpersonal skills and superior ability to work effectively in both independent and in a team or collaborative environment.
- Superior oral and written communication skills, including superior ability to draft and edit written reports of varying length and complexity, and to communicate effectively with audiences of varying seniority and expertise.
- Superior ability to anticipate issues relevant to the IC and United States Government and recommend/implement needed actions.

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
