## Position Information

This is an opportunity for:

## Who May Apply

Current GS employees at the same grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

## **Salary Determination**

- The ODNI uses a rank-in-person system in which rank is attached to the individual.
- A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Provides academic and registration counseling for students in assigned area of responsibility; conducts academic audits and conducts registration activities.

Compiles and analyzes registration related reports.

Participates in planning and execution of the annual commencement ceremony, including maintaining the accuracy of graduation program and script.

Responds to OPM investigators regarding academic standing of university students.

Performs other duties as assigned.
