## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade as the advertised position grade may apply.)

## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.



- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## Component Mission

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President and the National Security Council for intelligence matters related to national security; and oversees and directs the implementation of the National Intelligence Program. The DNI leads intelligence integration and forges an intelligence community that delivers the most insightful intelligence possible.

The Deputy Director of National Intelligence for Enterprise Capacity (DDNI/EC) is responsible to the DNI for all matters pertaining to IC resources, workforce, systems, technology and infrastructure, with five reporting components: Acquisition, Procurement and Facilities, IC Chief Financial Officer, IC Chief Human Capital Officer, IC Chief Information Officer, and Systems & Resource Analyses.

## Major Duties and Responsibilities (MDRs)

- Provide leadership, integration and engineering expertise in the IC Reference Architecture Framework and process to ensure consistent, repeatable, and verifiable results; fostering IC ownership towards the achievement of desired outcomes in an integrated approach.
- Provide leadership in conducting engineering and interoperability assessments.
- Build and extend IC-Wide trusted partnerships to identify validated IT needs and then drives the IT needs-to-requirements governance process.
- Leads a team to provide technical integration guidance, oversight, and facilitation to SMEs and Integrators of Intelligence Mission and Business Applications, services, tools, and data to be hosted in the IC Information Environment.
- Provides technical inputs to the Compliance Assessment Framework process milestone reviews.
- Provides end-to-end and leads systems engineering analysis to ensure compliance and resolve issues for key IC IT programs.
- Facilitates the analysis, planning, resource allocation and strategy for system enhancements, new technology insertion and divestment decisions for legacy system.
- Provides the engineering analysis, documentation, and activities needed to support release and deployment of services and systems.
- Leads the development of interoperability test plans, building upon the component test plans developed by the service providers; coordinates the testing of new capabilities with other elements to ensure that all equities are covered in the test process; serves as the independent validation and verification test director, conducting the technical functionality testing and coordinating the activities of other elements as they conduct analysis and accreditation testing and the user functionality testing.
- Leads a team of professional staff and assess performance, collaborate and oversee goal setting, and provides feedback on professional development.



- Deconflict complex functional requirements into underlying technical requirements and recommend “best fit” allocation of those requirements. Lead the development of technical and systems requirements.
- Design engineering solutions and alternative design options to meet customer requirements and provide guidance to junior engineers in the design and development of engineering solutions.

## Mandatory and Educational Requirements

- Experience in cross-community complex programs and making expert recommendations to improve products and services; considerable ability to deal with service failures and prioritize customer needs.
- Expert ability to quickly identify and apply new technologies, methodologies, and technical languages.
- Expert understanding of systems specifications and design.
- Expert knowledge of one or more IT specialties (hardware, software, networks); broad knowledge of other related disciplines.
- Superior ability to listen to, clarify, and convey understanding of others’ ideas, comments, and questions as well as to integrate and build upon diverse opinions in a manner that encourages the formation of integrated solutions and positions.
- One year of specialized experience at the next lower GS-grade (or equivalent). IT-related experience may be demonstrated by paid or unpaid experience and/or completion of specific, intensive training (for example, IT Certification). IT-related experience demonstrating each of the four competencies (Attention to Detail, Customer Service, Oral Communication, and Problem Solving).
- Bachelor’s degree in business, computer science, engineering, information science, information systems management, mathematics, operations research, statistics, or technology management or degree that provided a minimum 24 semester hours in one or more of the fields identified above and required the development or adaptation of applications, systems or networks.
- Experience in the integration of disparate systems or solutions.

## Desired Requirements

- Experience in the development and implementation of Reference Architectures.
- Master’s degree in business, computer science, engineering, information science, information systems management, mathematics, operations research, statistics, or technology management or degree that provided a minimum 24 semester hours in one or more of the fields identified above and required the development or adaptation of applications, systems or networks.
- Certifications/Licenses: FAC-C P/PM or equivalent PM certification; DOD Level III PM certification. Certification as an IT architect or enterprise architect from the Open Group, FEAC , or other industry recognized IT architecture certification program preferred.
