Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs)

- The Identities Innovation Officer will support Center efforts for discovery, analysis, watchlisting and screening and information sharing of identity information
- Identify priority requirements for new capability development and work with capability development partners to track, manage, and see those requirements thru implementation.
- Develop strategies for the synthesis of identity dimensions within DTI to inform future development of Terrorist Identities Datamart Environment (TIDE) database development.
- Form partnerships and collaborate with the USG Identity Intelligence Community. Build USG user-group communities and provide them supporting materials such as demos and documentation.
- Ensure identities' exploitation efforts are synchronized with community planning efforts and activities of partner agencies.
- Evaluate how identities information is captured, utilized and exploited across the Center with emphasis on business processes, current technology, and tradecraft and future development needs.
- Minimize internal and external duplicative efforts and identify gaps and impediments and develop mitigation recommendations.



- Anticipate emerging issues and proactively develop recommendations to address.
- Advise on strategic direction of identities analysis in watchlisting, targeting and information integration efforts.
- Clearly articulate strategic initiatives, anticipate resistance areas, and develop diplomatic ways to win others over and alleviate concerns, and lay out concrete implementation plans supported by stakeholders.
- Identify gaps and impediments in identity intelligence integration and recommendations for policies/procedures designed to reduce these gaps.
- Coordinate interagency and cross-directorate collaboration on identities topics.
- Plan and prepare written presentations and oral briefings for senior federal official and internal customers on significant issues pertaining to and/or affecting terrorist identities intelligence and analysis (including identities and the future of identities).

Mandatory and Educational Requirements

- Strong knowledge of program management and the life-cycle of capability development from requirements gathering to user outreach.
- Strong knowledge of identities analysis coupled with extensive knowledge of associated interagency databases and information sharing policies.
- Strong experience with and knowledge of the IC, counterterrorism and intelligence policy, intelligence operations, and situational awareness.
- Strong knowledge of the mission, charter, roles, and responsibilities of the ODNI, IC, and USG agencies, and how these organizations can effectively integrate their identities capabilities.
- Strong ability to lead, plan, promote, and share information and knowledge within ODNI, across the IC, and with other government agencies, and in doing so, effectively recognize, value, build, and leverage diverse and collaborative networks within these organizations.
- Superior ability to listen to, clarify, and convey understanding of others' ideas, comments, and questions as well as to integrate and build upon diverse opinions in a manner that encourages the formation of integrated solutions and positions.
- Knowledge of critical mission technology and information sharing issues related to "Big Data" from both mission user and IT perspectives.
- Superior ability to work well in a team environment and build coalitions with NCTC, ODNI and IC elements to achieve common goals.
- Demonstrated ability to communicate clearly, both orally and in writing.
