## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.



- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or one grade lower as the advertised position grade may apply.)

## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## Component Mission

The mission of the National Counterintelligence & Security Center is to lead and support the U.S. Government's counterintelligence (CI) and security activities critical to protecting our nation; provide CI outreach to U.S. private sector entities at risk of foreign intelligence penetration; and issue public warnings regarding intelligence threats to the U.S.

## Major Duties and Responsibilities (MDRs)

Plan, develop and present findings, conclusions, options, and recommendations to ODNI senior management.

Plan develop and lead NCSC's internal process to draft written responses to congressionally directed actions and congressional requests for information for submission to the ODNI Legislative Affairs office.

Lead NCSC's internal analysis of pending and expected legislation that affects the CI and Security mission areas and National Counterintelligence Strategy priorities. Produce written reports and summaries for NCSC leaders.

Lead NCSC's internal process to develop comments/feedback to pending legislation via the Office of General Counsel's Legislative Referral Memorandum process.

Support the NCSC mission group's Counterintelligence and Security resource advocacy efforts.

Develop, in accordance with other NCSC directorates and offices, background papers, talking points, and issue papers to inform NCSC resource management decisions.

## Mandatory and Educational Requirements

Demonstrated knowledge of analyzing trends and developments in proposed and existing legislation with the potential to affect NCSC relative to the counterintelligence and security mission.

Superior oral and written communication skills, and ability to conduct independent research, filter and synthesize data, and produce clear, logical, and concise products.



Experience with and knowledge of counterintelligence missions and activities.

Demonstrated knowledge of the ODNI and the Intelligence Community.

Demonstrated ability to identify emerging trends and strategic issues and incorporate these in developing strategic plans for the organization.

Bachelor's degree or higher.

## Desired Requirements

Expert knowledge of and experience working with the Intelligence Community's counterintelligence mission.

Extensive knowledge of IC and ODNI missions, organizations, roles and responsibilities and experience with the Intelligence Planning, Programming, Budgeting and Evaluation process.

Experience working for a congressional committee or with the legislative drafting process.

## Key Requirements and How To Apply

Internal ODNI Candidates:

A complete application package must include:

- A. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- B. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- C. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- D. **COVER LETTER:** Applicants must submit a cover letter as a supplement to the resume to elaborate on their qualifications and previous work performed.

polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified [IC Joint Duty Program website](#).**

## **Applicants from federal agencies outside the IC must provide:**

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- d. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
- e. **COVER LETTER:** Applicants must submit a cover letter as a supplement to the resume to elaborate on their qualifications and previous work performed.
