Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)



- For a detailee assignment:
 - Current Federal Government employees.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs)

- NCTC/DI is seeking an energetic officer to serve as a Tradecraft Reviewer on the Tradecraft Reviewer Cell in the DI/FO. • This position requires the skills of a motivated self-starter with excellent interpersonal skills who can work collaboratively with analysts, managers, designers, cartographers, and the President's Analytic Support Staff at CIA to ensure our senior intelligence consumers receive the highest quality counterterrorism-related finished intelligence. • Review PDB, NTB, and Current products to ensure they adhere to DI tradecraft principles. • Review draft publications for clarity, brevity, organization, logic, and grammar, and work with authors to add context as necessary; ensure that the information selected is relevant and adds-value to the intelligence products and ensure that each publication is concise and easily understood for policymaker customers. • Provide timely feedback to analysts and managers as appropriate in a constructive manner. • Ensure publications provide compelling and convincing information to support arguments contained in the intelligence publications. • Superior time management skills and ability to prioritize tasks with competing deadlines and superior ability to work effectively under extremely tight deadlines. • Cultivate and maintain productive relationships with intelligence officers to provide direct input in substantive and procedural processes for producing Community-coordinated intelligence analysis. • Serve as a Front Office representative in assisting analysts in conceptualizing products and in providing tradecraft and writing feedback to analysts and managers. • Manage the workflow of production after hours. • SIOs work a flex schedule covering three days each week, from Wednesday through Friday. Hours are normally 11 am to midnight, but occasionally go later if necessary to get the job done. Appropriate overtime, holiday pay, and night differential are available.

Mandatory and Educational Requirements

- Demonstrated analytical and critical thinking skills, including superior ability to think strategically.



- Extensive knowledge of the high priority issues and items of interest to intelligence publications' customers.
- Demonstrated interpersonal skills and superior ability to work effectively with individuals at the highest levels of government; confidence and effectiveness in working with government officials as well as with senior Office of the Director of National Intelligence (ODNI) officers.
- Demonstrated time management skills and ability to prioritize tasks with competing deadlines and superior ability to work effectively under extremely tight deadlines.

Desired Requirements

- Previous experience reviewing finished intelligence products.
- Penchant for thoroughness and a sharp eye for detail.
- A willingness to innovate. Ability to identify opportunities to improve on existing capabilities and practices and to follow through with practical, collaborative, and creative solutions.
- Strong mentoring skills and experience providing guidance to other officers, including managers.

polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified [IC Joint Duty Program website](#).**

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- d. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record.
