Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs)

- NCTC's National Intelligence Manager for Counterterrorism (NIM-CT) Office is a small group looking to add an impact-focused and collaborative team member. We work to align the Intelligence Community's (IC) direction with the National Security Strategy through the development of strategies and methodologies intended to guide IC CT collection and analysis. A significant portion of NIM-CT efforts deal with writing strategic products, collaborating and coordinating with ODNI and IC community offices, and keeping senior IC officials aware of enduring CT challenges. NIM-CT also serves as an advocate for the CT community's budget allocation requests through participation in the Intelligence Planning, Programming, and Budgeting Execution (IPPBE) process.
- NIM-CT is looking for an active collaborator and team player who can lead all aspects of product development in a strategically-focused environment, and who has an interest in – even with no prior experience – the CT threat the nation faces and the efforts and strategies the IC is employing to combat these threats. This person should have above-average writing skills, in order to draft, edit, and review products viewed by the most senior officials in the intelligence community and National Security Council (NSC). Responsibilities include:
 - Establishing relationships with offices throughout the ODNI and CT directorates/offices and all IC agencies.
 - Understanding and advocating for resource allocations that enable the IC to effectively combat the diverse threat our nation faces.
 - Maintaining insight and understanding of customer requirements related to counterterrorism (CT) intelligence gaps.
 - Analyzing mission effectiveness of proposed NIP and MIP funded capability requirements through strategic planning, independent analyses, and program evaluation.



- Identifying CT capability gaps, potential mission or enterprise needs and intelligence capability proposals.
- Planning and executing studies and performance modeling of proposed IC CT capabilities.
- Analyzing data to support the development of alternative approaches for IC CT programs, requirements, and budgets to establish priority objectives, address projected threats, estimate costs, risk and tradeoffs, and identify/minimize resource constraints.
- Conducting in-depth, detailed analysis and evaluation of proposed NIP investments to independently document mission and cost effectiveness levels.
- Conducting in-depth analysis of NIP policies, missions, plans, and capabilities, ensuring linkage to the NIS and other IC CT priorities.
- Drafting presentations of findings, conclusions, options, and recommendations to NCTC, ODNI, and IC senior management.
- Analyzing and evaluating (on a quantitative/qualitative basis) the effectiveness of current and planned NIP investments in meeting established IC CT goals and objectives.
- Conducting independent analyses of IC CT capabilities and programs, to support presentations to the DNI on alternative courses of action, identifying cost and mission impacts and clarifying the advantages and disadvantages of each alternative.
- Assessing, documenting, and validating NIP funded CT capability requirements.

Mandatory and Educational Requirements

- Significant writing and editing skills.
- General knowledge of IC organizations' missions in order to develop the national-level strategies and policies necessary to support U.S. national security interests.
- Strong understanding of the IC's planning and budgeting process.
- Ability to conceptualize, organize, and draw inferences from incomplete data and present a compelling analysis of findings and issues; demonstrated ability to identify, articulate, document, and mitigate knowledge gaps or alternatives approaches.
- Ability to communicate clearly, both orally and in written reports, and to logically analyze, synthesize, and evaluate multiple sources of information for their inclusion in briefings and written documents.
- Organizational and interpersonal skills to facilitate diverse forums, manage competing priorities and advocate new ideas/concepts/processes; demonstrated ability to exercise independent judgment on time-sensitive issues and work collaboratively across the IC.
- Ability to develop effective professional and interpersonal relationships with peers and colleagues in the Office of the Director of National Intelligence (ODNI), the IC, and U.S. Government.



- Ability to direct taskings, assess and manage performance, collaborate on goal setting, and support personal and professional development of all levels of personnel.

Desired Requirements

- Experience leading strategic planning, managing, and directing the successful efforts of a government or private organization.
