Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

For a cadre assignment:

- Current ODNI permanent cadre.

For a detailee assignment:

- Current Federal Government employees at the same grade or up to one grade lower than the advertised positions grade may apply.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

The National Intelligence Council (NIC) consists of the most senior intelligence analysts supporting the Director of National Intelligence (DNI) in carrying out responsibilities as the head of the Intelligence Community (IC) and as the principal adviser to the President for intelligence matters related to national security. The NIC produces a variety of all-source, IC coordinated intelligence reports, including its flagship product, the National Intelligence Estimate, which represents the Intelligence Community's most authoritative statement on a key national security issue.

Major Duties and Responsibilities (MDRs)

Lead the IC's production of strategic analyses on issues of importance to US interests with respect to economic security issues, such as macroeconomics, trade, finance, and energy, working as part of the NIO for Economics team and with other regional and function NIO teams.

Draft expert analytic assessments on a broad range of economic security issues. Oversee the preparation, production, and coordination of IC-coordinated assessments on a broad range of global economic issues and serve as an honest broker for competing IC views.

Manage Community-wide coordination of National Intelligence Estimates and other community analytic assessments, such as Intelligence Community Assessments, National Intelligence Council Memoranda, and Sense of Community Memoranda on economic security issues.

Brief senior IC members, policymakers, military decision makers, members of Congress, and other major stakeholders on economic security issues related to your area of expertise.

Apprise the DNI on a broad range of economic security issues in support of his/her role as principal intelligence adviser to the President. This includes overseeing the preparation of background papers and briefing books for the ODNI's participation in National Security Council, Cabinet meetings, and other senior-level policymaking meetings.

Provide strategic input to establish national intelligence collection and analysis priorities, and in doing so identify critical intelligence gaps and support collection initiatives based on customer needs and analytic requirements.

Oversee the preparation of correspondence and/or products in response to congressional tasking, including testimony, talking points, and statements for the record for the DNI and senior DNI staff.

Establish and manage relationships with academia, the business community, and other non-government subject matter experts to ensure the IC has a comprehensive understanding of global economic, financial and energy issues.

Participate in meetings with foreign liaison on issues related to your expertise.

Recognize, value, build, and leverage diverse collaborative networks with the ODNI and across the IC.

Mandatory and Educational Requirements

Broad expertise in economic analysis, as demonstrated by education and relevant work experience either on a country, region, or globally. Deep expertise in at least one area of the economic security mission.

Proven ability to deliver strategic analysis on economic issues. Proven ability to synthesize complex issues involving economics and political economy for senior policymakers.

Proven critical thinking skills leading to drafting and preparation of finished intelligence assessments and other written products with emphasis on outstanding analytic tradecraft, clear organization, and concise, well-sourced, and logical presentations.

Excellent interpersonal and organizational skills and an expert ability to conceptualize and effectively lead complex analytic projects and promote consensus building across the IC when analytic views differ. Expertise working with all parts of the IC and senior US officials in order to shape analytic production and encourage sound tradecraft.

Excellent oral and written communications skills, including an expert ability to communicate effectively with all ranks of the IC, deliver effective oral presentations, represent the NIC in interagency meetings, and prepare finished intelligence assessments and other written products with emphasis on clear organization and logical presentation.

Expert ability to prioritize and manage multiple short-term and longer-term tasks and projects and perform senior staff functions as required. Demonstrated ability to deliver quality analysis on short timelines.

Creative problem-solving skills and superior ability to provide leadership in carrying out mission responsibilities.

Desired Requirements

Deep expertise in more than one area of the economic security mission.

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
