Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI cadre.
- For a detailee assignment:
 - Current Federal Government employees.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs)

- DTI's Intel Educator will provide and develop specific training to give officers knowledge and skills essential to performing DTI's mission. This individual will use established methods to conduct training needs assessments, develops learning objectives and course/program documentation, deliver instruction that elicits student participation and mastery of learning objectives, and reviews post-course evaluations. Training materials are based upon evolving policy and progressing technology. The position will require direct input and drafting of these policies, procedures and training materials.
- Apply analytic approaches and techniques to gain an in-depth understanding of complex analytical issues and incorporate into training products/briefs.
- Work with DTI employees in order to understand their changing needs and requirements, and gather and compile information to design training programs.
- Produce products for internal and external customers that provide training and/or guidance on complex issues.
- Obtain necessary information for customer briefings and answer customer questions using provided background information, acquired materials, or information furnished via consultation with IC experts; exploit internal and external online databases, pose and obtain answers to questions from appropriate organizational and IC sources, and consult with peers, colleagues, and components as necessary.
- Establish and maintain effective working relationships with counterparts in the CT, Intelligence, and Law Enforcement Communities to support NCTC mission requirements and analytic undertakings and to promote intelligence integration.



Mandatory and Educational Requirements

- Strong knowledge of training programs, courses, and other instructional methodologies, including the ability to identify, evaluate, and recommend appropriate coursework, programs, and solutions to develop required workforce skills and abilities.
- Strong knowledge of and experience in applying adult learning principles and methodologies to the design and/or selection of courses.
- Potential for leading a team of professional staff and assess performance, collaborate, and oversee goal setting, and provide feedback on personal development.
- Ability to exercise independent judgment on time-sensitive issues, to perform multiple tasks and assignments, and to change focus quickly as demands change.
- Ability to work productively in a fluid environment with changing requirements and priorities; ability to support group decisions and solicit opinions from coworkers.
- Creative problem-solving skills and initiative in carrying out mission responsibilities based on senior-level guidance.
- Ability to work effectively, both independently and in a team or collaborative environment, mentor junior colleagues, and demonstrate organizational and interpersonal problem solving skills.
- Ability to effectively communicate complex, multi-disciplinary ideas and insights.

- Strong analytic background.

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- d. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record.
- e. **COVER LETTER:** Applicants must submit a cover letter as a supplement to the resume to elaborate on their qualifications and previous work performed.
