## Position Information

**This is an opportunity for:**

- An internal or external candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply. Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- **For a cadre assignment:**
  - Current ODNI permanent cadre.



- Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply).
- Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply).
- Candidates outside the Federal Government.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply).

## **Salary Determination**

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## **Component Mission**

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

## **Major Duties and Responsibilities (MDRs)**

- Develop national intelligence and preparedness policy to support mission requirements, as needed.
- Design, develop and execute counterterrorism exercises that meet the needs of International, Federal, State, local, tribal and territorial partners.
- Design and develop crisis response and management exercises related to a variety of scenarios involving realistic terrorism events based on real-world tactics, techniques and procedures.
- Execute discussion and operational-based exercises focused on evaluating existing or developing new plans that support response efforts in preparation for and response to a major terrorist incident.



- Design and develop all types of exercise documentation, as outlined in the Homeland Security Exercise and Evaluation Program, to include scenarios, scripts, injects, exercise plans and control/evaluator handbooks.
- Provide advice to senior managers on exercise-related issues, policies and procedures.
- Maintain productive working relationships with International, Federal, State, local and private/public sector partners in order to effectively respond to their mission needs.
- Meet the mission and enterprise objectives of the National Intelligence Strategy or other national level guidance documents.

## Mandatory and Educational Requirements

- Thorough program management, analytic, and critical thinking skills, including demonstrated ability to conduct program and management assessments, to identify needs and requirements, and to develop non-linear process improvement recommendations for implementation across the IC.
- Thorough knowledge of IC organizations' missions in order to develop the national-level strategies and policies necessary to support NCTC's participation in exercise planning / evaluation.
- • Ability to work effectively with senior leadership to build consensus on contentious issues and to foster a collaborative work environment across the ODNI, IC and other mission partners.
- Thorough experience in designing, developing and participating in various exercise scenarios and making recommendations based upon analyzed outcomes.
- Ability to balance responsibilities among program/project activities; ability to manage transitions effectively from task to task, adapting to varying customer needs, or ongoing emergencies.

## Desired Requirements

- Demonstrated experience working within the counterterrorism community successfully leading or serving as representational lead for one or more phases of the exercise cycle commencing with planning through evaluation and recommendation development.
