Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.



Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
- For a detailee assignment:
 - Current Federal Government employees.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Mission Support Division (MSD) provides its customers with a full range of support services and integrated solutions needed to accomplish the Office of the Director of National Intelligence (ODNI) mission. MSD staff provide proactive, comprehensive support, delivered with efficiency, professionalism, and a strong focus on cost value. - Manage and oversee the development, improvement, and implementation of projects/initiatives within established policies and guidelines and establish performance metrics against ODNI objectives.
- Lead the planning, management, and coordination of operational and administrative matters, review and investigate issues, and develop solutions and options.



- Lead the planning and developing of strategic resource management plans and strategies, conduct program and systems analysis, and independently evaluate program.
- Manage and execute internal business management processes for the organization; ensure management and staff are kept abreast of emerging developments.
- Liaise and maintain effective working with key stakeholders, ODNI components, and other government agencies to address issues that span multiple mission or program areas.

Mandatory and Educational Requirements

- Superior strategic and tactical planning, critical thinking, and analytical skills in order to propose innovative solutions and implement change with resourcefulness and creativity.
- Strong critical thinking skills and an ability to think strategically and evaluate outcomes against goals and objectives.

Desired Requirements

- Superior problem-solving skills, including the ability to develop effective professional and interpersonal relationships with peers and colleagues in the ODNI, the IC, and U.S. Government and mission partners.
- Superior ability to communicate, both oral and written, complex information in a clear, concise manner that is targeted to and meets the needs of diverse audiences with different perspectives and objectives.
- Superior ability to conceptualize, organize, and draw inferences from incomplete data and present a compelling analysis of findings and issues; superior ability to identify, articulate, document, and mitigate knowledge gaps or alternatives approaches.
- Superior research, planning, and organization skills, and superior ability to manage changing and competing priorities under strict timelines while maintaining a high level of attention to detail.
- Level 1 COTR certification or ability to obtain certification within 30 days.

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
