Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade as the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of National Intelligence for Intelligence Integration (DDNI/II) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. DDNI/II is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DDNI/II is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DDNI/II is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

- Performing work in any of the areas of financial management which include advise on, administer, lead, or perform professional or technical work related to budget administration, financial analyses, advice, policy, procedures, controls, accounting, auditing, or similar nature when such work requires knowledge and application of financial management theories, concepts, principles, and standards applicable to the activities of the organization.
- Employ knowledge and skills related to budget and fiscal laws, regulations, policies, precedents, methods, and techniques to include analytical, technical, and administrative duties in one or more areas of the federal budgetary process in support of the organization's mission. The incumbent exhibits knowledge of the scope of laws, regulations, and policies that affect the organization's financial and accounting support systems, processes, and operations.
- Develop specific objectives and devise new methods, techniques, and criteria pertaining to such matters as identifying trends and patterns, acquiring information and analyzing data, developing solutions and presenting findings, and examining requirements for which there are no precedents.
- Analyze financial and budgetary relationships to develop recommendations for financial and/or budgetary actions under uncertain conditions or due to short and rapidly changing deadlines, guidance, or objectives.
- Prepare, justify, administer, analyze, and forecast budget resources to ensure cost-effective support of organizations and programs, including conducting budget or financial data analysis and assessing financial conditions by applying financial principles, policies, methods, techniques, and systems.



- Collect, research, and analyze comprehensive and substantive financial information that includes any area of budgeting, accounting, auditing, financial planning, and financial reporting to develop reports, testimony, briefings, and talking points for senior DNI leadership, the Office of Management and Budget, or Congress.
- Apply IC-wide and ODNI regulations and standardize financial management processes and procedures to improve the quality of financial reporting.
- Prepare, analyze, and forecast budgetary and financial information to evaluate continual change in program plans and funding and their effect on financial and budget program milestones.

Mandatory and Educational Requirements

- Demonstrated knowledge of departmental or agency financial management policy, regulations, and financial systems and ability to apply sound and independent judgment in order to resolve financial problems.
- Demonstrated ability to independently plan and conduct a variety of assignments, assessments, examinations, or investigations.
- Experience conducting accounting and financial reporting of information through a thorough knowledge of financial principles, policies, methods, techniques,

Desired Requirements

- Understanding of and experience with CIA/ODNI financial systems.
- Ability to work effectively at a senior level within an interagency environment on complex issues requiring negotiation and consensus-building skills.
- Strong oral and written communication skills, including ability to clearly convey complex information and present findings to all levels of management.
