Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI), Directorate for Mission Integration (DMI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the Intelligence Community (IC) enterprise. DMI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DMI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DMI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components in support of the National Intelligence Managers (NIMs) and to advance the Unifying Intelligence Strategies (UIS). The National Intelligence Council (NIC) consists of the most senior intelligence analysts supporting the Director of National Intelligence (DNI) in carrying out responsibilities as the head of the Intelligence Community (IC) and as the principal adviser to the President for intelligence matters related to national security. The NIC produces a variety of all-source, IC coordinated intelligence reports, including its flagship product, the National Intelligence Estimate, which represents the Intelligence Community's most authoritative statement on a key national security issues.

Major Duties and Responsibilities (MDRs)

- Work closely with National Intelligence Council (NIC) authors, tradecraft specialists, and the NIC Front Office to conceptualize and then deliver graphic products that provide clear and novel insights.
- Apply principles and theories of graphic design, data visualization, statistics, cartography, geography, color theory, layout, and typography to implement design ideas that communicate effectively.
- Keep up-to-date with graphic design technologies, tools, techniques, and trends.
- Develop best practices and standards for NIC visuals and finished production templates.
- Assist in developing criteria and a follow-on process for evaluating whether a visual or map is required for a NIC product.
- Mentor other designers, cartographers, and NIC authors in visualization theory and techniques. Lead workshops on design, software tips, and related topics.
- Coordinate closely with the many disciplines involved in production, including other designers, cartographers, publications officers, authors, and the NIC FO.

- Participate in relevant IC groups that correspond to the production of visuals in finished intelligence.
- Proactively seek feedback from customers to improve the relevance, quality, and timeliness of NIC visuals.
- Attend the NIC's Editorial Review Board to receive feedback on the use of visuals in NIC publications.
- Build and leverage diverse collaborative networks within the ODNI and across the IC.

Mandatory and Educational Requirements

- Strong critical thinking and writing skills.
- Demonstrated ability to produce visuals for finished analytical products.
- Previous experience in leading conceptualization sessions and assisting authors in discerning whether a visual is required, and if so, how to most effectively communicate the analytical story in a visual.
- Demonstrated ability in the use of a broad range of graphic tools and approaches to present data, including Adobe Creative Suite (primarily Illustrator, InDesign, Photoshop, and Acrobat) and mapping software, such as ArcGIS and Avenza MaPublisher.
- Strong interpersonal, organizational, and problem-solving skills.
- Demonstrated ability to work effectively both independently and in a team.
- Thorough knowledge of copyright laws.
- Creative problem-solving skills and initiative in carrying out mission responsibilities.
