Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or up to one grade lower than the advertised position grade may apply.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees at the same grade or up to one grade lower than the advertised positions grade may apply.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

Direct and oversee programmatic operations of the NIM South Asia office and liaise with senior officials to ensure strategic alignment and direction with the ODNI staff and IC mission enterprise.

Foster and cultivate strategic alliances and professional networks with interagency partners and other community elements to facilitate priority attention on National Intelligence Strategy, NIM South Asia's UIS, and Intelligence Reform and Terrorism Prevention Act requirements.

Maintain situational awareness of significant issues affecting NIM South Asia in general, India in particular, and the broader community and alert senior NIM South Asia and ODNI / DDII staff regarding emerging issues that affect the office.

Lead cross-ODNI collaboration to ensure customer requirements and priorities align with IC mission, goals and objectives in Near East as they address progressive policy requirements, collection emphasis, and federated community production.

Lead the development and preparation of internal and external memoranda, tasking responses, and other correspondence, to include policy analysis documents in response to tasking from policymakers.

Brief senior IC leadership, Department of Defense (DoD) officials, members of Congress, policymakers, and other major stakeholders as necessary on NIM South Asia initiatives, challenges and opportunities.

Represent NIM South Asia, in his/her absence at internal and external meetings, conferences, and other public fora.

Develop the unifying vision to bring collaboration tools, data, and processes into a seamless user experience.



Mandatory and Educational Requirements

Expert knowledge of IC members; their missions, structures, capabilities, processes, policy development, and tradecraft programs.

Expert knowledge of IC all-source analysis, collection, and mission management activities across all intelligence disciplines.

Expert knowledge of ODNI organization, mission, and objectives.

Superior analytical and critical thinking skills, including the ability to think strategically, identify needs and requirements, develop recommendations, and evaluate outcomes against goals and objectives.

Superior leadership skills and ability to lead interagency working groups and initiatives to synchronize and advance UIS objectives.

Superior interpersonal skills and ability to work effectively, independently, and in a team or collaborative environment.

Expert ability to design and implement integration strategies for IC initiatives and programs, including the ability to manage human, financial, and information resources.

Expert ability to observe, measure, and evaluate outcomes against goals and objectives and direct the development and implementation of solutions and/or organizational changes.

Superior oral and written communication skills with demonstrated ability to view substantive and administrative issues, exert influence to senior leadership, communicate effectively with people at all levels (both internal and external), brief management on reviews and findings, and organize and edit written reports of varying length and complexity.

Applicants from federal agencies within the Intelligence Community (IC) may be considered for this position as a reimbursable detailee, if endorsed by the employing agency. Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
