This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.



- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

National Security Partnerships synchronizes IC support and whole of government efforts with federal, state and local governments, the private sector and the Department of Defense, ensuring IC outreach is coordinated, timely and relevant. It also provides key leadership for activities in four domains that operate across national sectors – aviation, maritime, space and cyber -- bringing the IC's activities in these domains into alignment, and facilitating coordinated engagement internal to the ODNI, across the IC and with the rest of the federal government.

Major Duties and Responsibilities (MDRs)

- Assist the Cyber Senior Coordinating Official (SCO) with incorporation of Cyber domain priorities and requirements into strategic planning across ODNI functions to include National Security Partnerships (NSP), Mission Integration, Enterprise Capacity, Strategy & Engagement, National Counterproliferation Center, National Counterterrorism Center, National Counterintelligence & Security Center and Cyber Threat Intelligence Integration Center. Advise the DD-NSP, NIM-Cyber, NIMC, and other ODNI leadership on critical cyber intelligence issues, developments, opportunities, and threats. Facilitate strategic planning with NSP elements (Domain Coordination, IC-DOD Coordination, Federal-State-Local Partnerships and Private Sector) to develop coordination objectives based on the SCO's priorities and requirements. Facilitate incorporation of Cyber domain priorities and requirements throughout entire IPPBE cycle, to include coordinated preparation for Congressional budget actions. Identify and coordinate accesses for CAP, SAP, and ACCM program to support Cyber campaign development.

Mandatory and Educational Requirements

- Knowledge of the IC, intelligence policy, intelligence operations, and Cyber-related intelligence issues. Experience and knowledge of inter-agency coordination processes and operations to sustain effective working



relationships with other U.S. Government departments, agencies, and centers Experience formulating, coordinating, and participating in the execution of strategic plans with achievable measures of progress and reflecting a diversity of stakeholder equities. Ability to lead, sustain, and support cooperative relationships between organizations and to develop and execute effective plans for complex interagency projects. Strong interpersonal, organizational, and problem-solving skills, including demonstrated ability to work effectively both independently and in a team or collaborative environment. Experience translating broad statements of national level policy guidance into organizational guidance and implementation planning.

Desired Requirements

- Experience managing analysis, operational support or intelligence production related to long and short term requirements. Experience with engagement and outreach opportunities to facilitate collective decision-making and to represent broad interagency Cyber interests. Experience with organizational change, transformation, or reorganization.
