Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President and the National Security Council for intelligence matters related to national security; and oversees and directs the implementation of the National Intelligence Program. The DNI leads intelligence integration and forges an intelligence community that delivers the most insightful intelligence possible. The Deputy Director of National Intelligence for Enterprise Capacity (DDNI/EC) is responsible to the DNI for all matters pertaining to IC resources, workforce, systems, technology and infrastructure, with five reporting components: Acquisition, Procurement and Facilities, IC Chief Financial Officer, IC Chief Human Capital Officer, IC Chief Information Officer, and Systems & Resource Analyses. The Assistant Director of National Intelligence for Systems and Resource Analyses (ADNI/SRA) is the principle staff assistant and advisor to the Director of National Intelligence (DNI) on matters pertaining to program analyses, evaluation, and resource allocation through independent analyses and advice relevant to the National Intelligence Program (NIP) and the Military Intelligence Program. As the principle advisor to the DNI on these matters, the ADNI/SRA analyzes, evaluates, and provides alternative plans, programs, and budgets for DNI priority objectives, projected threats, estimated costs, and resource constraints.

Major Duties and Responsibilities (MDRs)

- Lead the integration and synchronization of the Intelligence Planning, Programming, Budgeting, and Evaluation (IPPBE) system. Develop methodologies and analysis to inform and support alignment of resources to strategy and priorities. Develop the Consolidated Intelligence Guidance (CIG), which documents IC strategic priorities and conveys DNI priorities and strategic outcomes for building the intelligence program and budget.
- Oversee and direct independent analysis, studies, and evaluations on NIP programs. Ensure rigor and currency of analytical methodologies; document processes; modernize tools; institute best practices for measuring program success, outcomes, and impact. Guide development of performance and resource recommendations to support the IC's overall attainment of the U.S. Government's strategic objectives.
- Collaborate with peers and senior officers across Enterprise Capacity, ODNI, and the IC to further DNI priorities on resource-related matters.
- Lead and grow a team of expert cadre, joint duty, and contractors executing the SRA mission, successfully managing complex programs and projects that may include ill-defined requirements, ambiguity, parallel tasks, multiple dependencies, and high risks; ensure timelines, costs, deliverables, and outcomes meet DNI programmatic goals.



- Develop, evaluate, and analyze project proposals and action plans; determining impact on current resources, and forecasting resource needs.

Mandatory and Educational Requirements

- Expert ability to apply analytic, quantitative, and qualitative techniques to identify, evaluate, and recommend alternative approaches to challenges in the IC.
- Experience managing complex issues between the Department of Defense, Office of Management and Budget, ODNI, and IC Components.
- Excellent critical thinking skills, including the ability to conceptualize and lead complex analytic projects and develop structured recommendations and solutions.
- Excellent oral and written communication skills, the ability to filter and synthesize analytic data, and produce clear, logical, and concise products to audiences of all levels of expertise.
- Experience developing and implementing strategic planning processes and measures of success.
- Excellent interpersonal skills and the ability to work effectively with senior leaders from inside and outside the USG, and a professional network across the IC.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified [IC Joint Duty Program website](#).**

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
