## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees at the same grade or one grade lower than the advertised grade may apply.



## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail assignment, will be assigned to the position at his or her current grade and salary.

## Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

## Major Duties and Responsibilities (MDRs)

Evaluate the application of IC Analytic Standards in analytic products, produce evaluation reports and studies, and discuss analytic tradecraft performance in collaborative settings with consumers.

Apply deep expertise of analytic tradecraft to advance the development of tradecraft guidelines, standards, or best practices.

Lead AIS's efforts to develop, implement, and connect IC elements with appropriate training; serve as POC for AIS's online analytic evaluator course, on which elements' evaluation programs rely to train their evaluators.

Lead calibration exercises with IC element evaluation programs to assess similarities and differences between AIS's and programs' evaluations; share best practices in evaluation.

Identify exemplary analytic products and post exemplars to AIS's website.

Participate in subcommittees or working groups to find ways to improve analytic tradecraft.

Foster IC evaluation program integration; enhance analytic evaluation methodology and develop new and effective ways to translate evaluation results and feedback into improved analytic product quality across the IC.

Cultivate an IC-wide network to understand and advance methods, tools, and training to enhance analysis and evaluation practices.

Lead, cultivate, and maintain positive customer relationships in order to gather input and feedback for addressing analytical issues; provide effective briefings to senior internal and external customers on the analytical content of complex intelligence products and the development of future analytical tools and methodologies.



## Mandatory and Educational Requirements

Expert knowledge of ICD 203 Analytic Standards, analytic evaluation methods and tools, ability to plan and conduct complex methodological analyses, and ability to manage and assess complex datasets.

Superior ability to present sensitive, controversial, statistical and other information in briefings or written products and communicate effectively with senior executives and other customers.

Superior situational judgment and superior interpersonal, negotiating, and networking skills to work collaboratively and build strong team relationships across occupations and organizational boundaries with customers, service providers, and staff.

## Desired Requirements

Ten years of relevant IC work experience or five years of outside relevant experience and five years of IC experience in analysis or related discipline is preferred.

Prior analytic evaluation experience, such as the preparation of analytic line reviews, post mortems, or product evaluations.

Contracting Officer Technical Representative level 1 Certification.

## **CURRENT FEDERAL EMPLOYEES APPLYING FOR A DETAIL ASSIGNMENT:**

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

## **Applicants from federal agencies outside the IC must provide:**

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **POSITION NUMBER:** Reference the position number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
