Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:



- Current Federal Government employees at the same grade as the advertised grade may apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail assignment, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

As part of the knowledge management team of the Identity Intelligence (I2) division, you will assist to build a unified, integrated I2 Enterprise (I2E) that will support all intelligence and national security missions. You will also:

Cultivate and curate identity intelligence data and develop data sharing strategies and policies for integrating a wide range of multi-source, complex, uncommon and unstructured data into a framework to support all IC and national security missions.

Develop, nurture, and, maintain productive working relationships with enterprise peers across the IC and USG in order to coordinate data curation and collection strategy activities and evolving requirements and to promote the implementation of mission and enterprise objectives.

Provide analysis and recommendations to ensure that I2E partner element plans, programs, and agreements align with objectives of the strategic plan by assessing and evaluating progress toward mission and enterprise objectives to determine how well the Enterprise is postured for future environments.

Advise and engage I2D leadership on strategic priorities, opportunities, gaps, lead and oversee the communication of emerging strategic issues and trends, independently evaluate against IC strategic elements, and make recommendations for improvements.

Develop the unifying vision to bring collaboration tools, data, and processes into a seamless user experience.

Mandatory and Educational Requirements

Extensive knowledge of IC organizations; IC mission posture, structures, capabilities, processes, policy development



Have significant experience in two or more of the following: identity intelligence, analysis & production, collection, requirements, information technology, systems design and architecture.

Demonstrated leadership skills and ability to lead interagency working groups, build coalitions with IC elements to achieve common goals.

Have subject matter expertise in planning and assessment of information operations and enterprise program management in a complex strategic-level environment with experience conceptualizing and developing various forms of strategic communications, programmatic tools, and other collateral materials.

Demonstrated analytical and critical thinking skills, including the demonstrated ability to think strategically, identify needs and requirements, develop recommendations, and evaluate outcomes against goals and objectives.

Demonstrate independent development, implementation, and management of comprehensive planning and strategic information related activities and special access programs in linear and non-linear environments.

Demonstrated interpersonal skills, oral, and written skills with superior ability to work effectively in both independent and in a team or collaborative environment.

Experience developing and conducting assessments of performance against enterprise systems and multi-intelligence priorities.

Desired Requirements

Knowledge of I2 threat actor categories and genesis, targeting, metrics analysis, measures of effectiveness, intelligence data interpretation, augmented intelligence, course of action and estimative analysis.

CURRENT FEDERAL EMPLOYEES APPLYING FOR A DETAIL ASSIGNMENT:

Applicants from federal agencies within the Intelligence Community (IC) may be considered for this position as a reimbursable detailee, if endorsed by the employing agency. Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **POSITION NUMBER:** Reference the position number in the subject line of the email and on each document submitted.
