Position Information

This is an opportunity for:

- An internal candidate to fill a GS-12 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply).



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission:

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs):

This position is part of the Directorate of Identity Intelligence (DII) Team responsible for mission innovation. This individual will provide education & compliance along with strong critical thinking and communication skills to DII analysts and to external agencies and personnel with a request for Terrorist Identities DataMart Environment (TIDE) and watch listing familiarization. The branch is also responsible for ensuring internal compliance with watch listing guidelines, internal policies, analytic standards, and civil liberties and privacy, through such things as routine audits. Duties include:

- Develop Directorate wide training criteria and plans ensuring cross-directorate sharing of techniques and tactics to resolve identities, ensure compliance against Watch listing standards, and pursue terrorist networks to their source.
- Identify mechanisms to modernize training for staff, through collaborative approaches with online training and other centers of excellence and education throughout the IC.
- Develop standards for compliance with watch listing guidelines, internal policies, and analytic standards, and conduct routine audits to ensure compliance and quality of work.
- Communicate regularly with internal and external peers and counterparts on standards, processes, and techniques.



- Establish and maintain effective working relationships with counterparts in the CT, Intelligence, and Law Enforcement Communities to support NCTC mission requirements and analytic undertakings and to promote intelligence integration.
- Communicate regularly with internal and external peers and counterparts on standards, processes, and techniques.

- Ability to remain open-minded and change opinions on the basis of new information and requirements; basic ability to support group decisions, accept and incorporate feedback, and solicit opinions from coworkers.
- Knowledge of IC organizations, policies, and procedures, and their requirements with regard to terrorist identities intelligence research and analysis.
- Demonstrated ability to communicate clearly, both orally and in writing.
- Demonstrated ability to research and logically analyze, synthesize, and judge information, as well as the ability to review and incorporate multiple sources of information in performing assignments.
- Interpersonal, organizational, and problem-solving skills, including a demonstrated ability to work effectively within an interagency environment on complex issues requiring negotiation and consensus-building.
- Demonstrated ability to work under pressure with strict deadlines while maintaining a high level of attention to detail.
- Experience with quality control, quality assurance, auditing, and/or data integrity efforts.
