Position Information

This is an opportunity for:

- An internal or external candidates to fill a GS-13 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or up to one grade below may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.

- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or up to one grade below may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual.
- A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Component Mission:

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities:

- The National Counterterrorism Center's Directorate of Intelligence (NCTC/DI) is seeking an experienced GS-13 Analyst with strong leadership, tradecraft, digital acumen, and interpersonal skills to serve as a targeting analyst in our DOMEX Cell. The analyst will work with the DI's DOMEX Lead / SME to help position the DI to leverage the DOMEX data it has to analyze threats, warn of new threats, and deliver value-added, timely data analytic services and reports to a broad range of customers and partners.
- NCTC/DI has begun a shift toward data-driven analysis and is seeking an experienced analyst with a strong technical background to help drive our efforts to synthesize the work from creative and empowered media examiners, data scientists, methodologists, and strategic analysts. The DI also works with partners across the IC to improve the DI's capacity to acquire, understand, use, and persistently search rapidly increasing and disparate data sources. The analyst will:
 - Work across the DI to innovate, apply, and integrate quantitative analyses into analytic production.
 - Help develop and sustain partnerships with both internal and external customers and stakeholders, providing tailored analytic support, as needed.

- Facilitate access to Community exploitation resources and interact with DOMEX owners, producers, and consumers to improve discovery and use of DOMEX derived information.
- Explore emerging technologies and other means to help automate discovery and access to relevant information in disparate DOMEX datasets.
- Assist with the examination of raw media / devices, answer ad-hoc requirements, construct cables and FINTEL, produce programmatic documentation, and interact with the relevant DOMEX units at FBI, DoD, DHS, CIA, and the National Media Exploitation Center on a regular basis.
- Actively participate in initiatives that advance the Center's DOMEX goals and help pioneer exploitation activities to provide relevant analytic, geospatial, and technical reporting of DOMEX.
- Drive the DI's conceptualization of complex DOMEX technical intelligence discoveries and help create and author timely and relevant DOMEX driven products.

Mandatory Requirements:

- Ability to effectively plan and execute the development of high-quality, complex analyses, studies, projects, assignments, and briefings on key US foreign policy and national security objectives focused on a specific regional area and/or functional issue for IC consumers and policymakers at the highest levels of government.
- Demonstrated success independently and in multidisciplinary teams as a Targeting Analyst, Media Exploitation Officer, or Technical Targeting Officer.
- Demonstrated ability to work well across organizational lines, breaking down stovepipes, and collaborating and communicating effectively across functional and geographic lines, and across organizations.
- Proven ability to participate in an inclusive environment; ability to clearly execute mission objectives and hold subordinates accountable for results.
- Demonstrated interpersonal skills and ability to build consensus, work effectively and independently.
- Demonstrated ability to plan strategically, analyze, and assesses initiatives.
- Demonstrated familiarity with DOMEX initiatives and workflow from an intelligence, law enforcement, homeland security and/or military background.
- Exceptional oral and written communications skills.
- Knowledge of technical targeting and DOMEX exploitation with an understanding of Community accepted exploitation tools.
- Exceptional critical thinking skills, including an ability to think strategically.
- Experience taking a corporate approach to help establish a sustainable program.

- Experience fusing raw DOMEX with other INTs to develop leads for operational customers.
- Knowledge of the NCTC and the counterterrorism community.

Key Requirements:

- Successful completion of CI polygraph and background investigation.
- Successful completion of an ODNI medical screening.
- A two-year trial period is required for all new permanent appointments to the ODNI.
