Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The mission of the National Counterintelligence & Security Center is to lead and support the U.S. Government's counterintelligence (CI) and security activities critical to protecting our nation; provide CI outreach to U.S. private sector entities at risk of foreign intelligence penetration; and issue public warnings regarding intelligence threats to the U.S.

Major Duties and Responsibilities (MDRs)

- The incumbent for this position will lead a small team of contract personnel responsible for analyzing resources and conducting IC-wide CI mission reviews and oversight of IC-wide CI and security performance metrics. The reviews are an annual evaluation of each IC agencies' progress toward achieving the objectives of the National Counterintelligence Strategy. The evaluations include discussion of shortfalls, their impact and causes, and recommendations to remedy those shortfalls. The team chief has a significant influence on shaping Director, NCSC's engagement with IC CI and Security Programs and drives annual substantive dialogue between Director, NCSC and IC CI and Security leaders on addressing agency successes and challenges. This portfolio offers broad exposure to senior IC officers working on resource issues and managing CI and Security programs. The incumbent will be expected to:
- Lead, plan, direct, and coordinate implementation of the reviews and management of IC CI and security-related performance metrics.
- Maintain, build, and leverage collaborative, productive working relationships with NCSC and ODNI colleagues and IC CI and Security elements.
- Attend internal and external training, seminars, and conferences relevant to CI and security issues, strategy, strategic assessment/evaluation, and performance management.
- Collaborate with IC CI and security elements to prepare for meetings with Director, NCSC to provide a review of progress, challenges, and requirements, and shape this engagement.
- Serve as a key knowledge broker on questions associated with IC progress toward achieving National CI Strategy objectives and CI and security-related performance metrics.



Mandatory and Educational Requirements

- Extensive knowledge of IC and ODNI missions, organizations, roles and responsibilities, and experience with intelligence policy, the IPPBE process, IC missions, and interagency coordination.
- Organizational, interpersonal, and leadership skills, including the ability to establish and lead collaborative efforts and broad-based teams, and balance responsibilities among program/project activities.
- Superior written and oral communication skills, with demonstrated experience communicating effectively with audiences of varying seniority and expertise, and drafting and editing clear, concise analytical products of varying length and complexity including evidence-based reports and charts.
- Superior critical thinking and problem-solving skills, including the ability to observe, measure, and evaluate outcomes against goals and objectives, identify needs and requirements, and develop recommendations.
- Experience with conducting mission reviews, performance reviews, and/or strategic assessments in the US Government, and knowledge of strategic planning.
- Education: Bachelor's degree or equivalent experience in Counterintelligence and Security.

Desired Requirements

- Experience with and knowledge of counterintelligence and security missions and activities.
- Experience with evaluating intelligence community performance.
- Experience with designing and conducting surveys or evaluations.
