Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

For a cadre assignment:

- Current ODNI permanent cadre.

For a detailee assignment:

- Current Federal Government employees at the same grade or one grade lower than the advertised grade may apply.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail assignment, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Intelligence University (NIU) is the Intelligence Community's sole accredited, federal degree-granting institution. NIU advances the intelligence profession through a holistic, integrative, contextual approach to education that promotes dynamic teaching, engaged learning, original research, academic outreach, analytical problem solving, rigorous research methods, collaborative processes, and lifelong learning.

Major Duties and Responsibilities (MDRs)

Incumbent serves as a Space and Counterspace faculty member at the National Intelligence University, teaching graduate courses in the Emerging Technologies and Geostrategic Resources (ETGR) concentration as well as core intelligence courses in the Oettinger School of Science and Technology Intelligence.

Incumbent may teach courses in space operations, foreign space capabilities, space commerce and economics, space science and technology, missiles, space ISR, and space warfare. Incumbent may also teach undergraduate courses.

Incumbent also will perform research and external engagement in his/her field of expertise, and will serve as a thesis advisor and reader.

Understands capabilities and limitations of intelligence collection and analytic methods.

Maintains active liaison with government and private sector civilian, military, educational individuals associated with intelligence.

Duties also include participation in relevant NIU and IC communities of interest and outreach to other IC and DoD agencies, USG organizations, and institutes of higher academia.

Mandatory and Educational Requirements

Earned graduate degree from an accredited university in the fields of natural science, engineering, computer and information sciences, mathematics and statistics, or a related area.

Demonstrated knowledge of space technology, or substantial experience working with space infrastructure, space operations, space intelligence, or space commerce.

Demonstrated experience in some or all the following areas: (a) evaluating or preparing analytical intelligence reports for senior US government or industry policymakers, (b) teaching courses at the graduate or undergraduate level, or (c) overseeing student or other research projects.



Demonstrated oral and written communication skills, including the ability to communicate complex information in a clear, concise manner that is targeted to, and meets the needs of, diverse audiences with different perspectives and objectives.

Publishes original research in peer reviewed journals or other professional outlets, OR maintains active liaison with government and private sector civilian, military, educational individuals associated with intelligence.

Desired Requirements

Earned PhD from an accredited university in natural science, engineering, computer and information sciences, mathematics and statistics, or a related area.

Demonstrated academic experience with teaching courses at the graduate level, conducting academic research and scholarship, writing and reviewing research papers and theses, and academic course and program development, including creating and evaluating academic assessment data and standards.

Experience with Intelligence Community operations, collections, analysis, or applications; including military intelligence.

Knowledge of or experience with aspects of (a) scientific research and development, engineering, test, and evaluation, OR (b) history, philosophy, or economics of science and technology, OR (c) biometric, forensic, or other techniques and databases for establishing, verifying, or falsifying the identity of individuals.

Knowledge or experience with assessment-based academic curriculum management.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **POSITION NUMBER:** Reference the position number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
